Cornell Cooperative Extension, the Cornell Vegetable Program, the Lake Ontario Fruit Team, the Produce Safety Alliance, and the Cornell National GAPs program, with assistance from the New York Department of Agriculture & Markets, will be hosting a training for farm food safety or Good Agricultural Practices (GAPs), including Harmonized GAPs.

In recent years, several food borne illness outbreaks in produce have made national news. Both the produce industry and the federal government have stepped up demands for fruit and vegetable farms to meet food safety practice standards. These standards are known as GAPs (Good Agricultural Practices).

A new program, **Harmonized GAPs**, has been developed to combine several food safety certifications into one program. New York's retail produce buyers are asking growers to adopt Harmonized GAPs certification in many cases. In response, Cornell National GAPs Program and Cornell Cooperative Extension have developed a multi-day workshop.
